Count One	Reckless Homicide - F3 O.R.C. §2903.041(A), 2903.041(B)
Date of Offense	On or about November 16, 2021

That Matthew Mooney, on or about November 16, 2021, at Erie County, Ohio, did recklessly cause the death of Wayde S Lafferty.

In violation of the Ohio Revised Code Section 2903.041(A), 2903.041(B) and against the peace and dignity of the State of Ohio.

That Matthew Mooney, on or about November 16, 2021, at Erie County, Ohio, did operate or permit the operation of a vessel in an unsafe manner.

FURTHERMORE, Matthew Mooney violated section 1547.07 causing injury to a person or damage to property.


In violation of the Ohio Revised Code Section 1547.07(B), 1547.99(E) and against the peace and dignity of the State of Ohio.
